The Carroll County Department of Planning has begun an update of the countywide comprehensive plan. It is organizing community meetings. The first so-called Grassroots Gatherings is scheduled for Finksburg on September 27<sup>th</sup> at Sandymount Elementary School's gymnasium at 6:30 p.m. The purpose of the Grassroots Gatherings community meetings is to get input from as many community members as possible on how to get where we think we want to go in the future.

#### **Smokers Barbeque Delayed:**

The owner of the proposed Smokers barbeque on Route 140 near Kays Mill Road has submitted another plan to county staff. Planning staff felt all of their concerns were not addressed in the original plan.

#### **Assisted Living Facility Hearing Rescheduled:**

The Board of Zoning Appeals has continued the conditional use and appeal hearing for the proposed Victory Springs assisted living facility until October 25<sup>th</sup>. The proposed 15-bed complex would be constructed at Route 91 and Hughes Road. Several Finksburg residents attended the first meeting. The next meeting will be held at 9:30 a.m.

#### **FPACC Planning Fall Meeting:**

FPACC is planning a major fall meeting. The tentative plan is to have a business expo. This would give all Finksburg businesses the opportunity to show and promote their business to residents. We will have more on this in the coming weeks.
