#### **Route 1 Project Manager To Speak:**

Dace Blaumanis of Howard County is scheduled to attend our next meeting to discuss the Route 1 Manual. She was the project manager and is responsible for much of the work that went into revitalizing Route 1 in Howard County. This presentation may be beneficial in helping Carroll County with ideas on how to improve the Route 140 corridor in Finksburg. We want to point out that FPACC is not endorsing the Route 1 project for implementation in Carroll County. We are only looking for ideas to make our community better.

#### **Horn Addresses FPACC Board:**

County Planning Director Steve Horn has also been invited to attend our next meeting to brief us on a proposed Route 140-Route 91 overpass plan the state is considering. FPACC's executive board met with Horn earlier this month and unanimously endorsed the plan. The proposal, which still needs state and county approvals, would include a Route 140 overpass over Route 91 to alleviate the congestion. Horn did say best-case scenario, the project is many years down the road.

#### **Redistricting Plan Public Hearing:**

The local delegation to Annapolis has scheduled an October 25<sup>th</sup> public hearing on the recently approved expanded Board of County Commissioners. The hearing will also give residents a chance to discuss whether they approve of the district-only voting process or whether they would like to vote for all five commissioners. The delegation may also look at how the five-district map is drawn up. Finksburg is split into two separate districts. The meeting will be held at 7 p.m. in room 03-04 of the County Office Building.

#### **Scenic Carroll Commission Update:**

FPACC Treasurer John Lopez, a member of the Scenic Carroll Commission, says the next SCC meeting is October 24<sup>th</sup> at 2 p.m. in room 007 of the County Office Building. The SCC is working on coming up with a design for "Welcome to Carroll County" monuments at the various gateways into the county, including Route 140 in Finksburg. Everyone is encouraged to attend the meeting

The second Grassroots Gathering in Finksburg meeting was held Tuesday night, October 18<sup>th</sup>. The meeting was well attended. #### **Project Proposals In Finksburg:**

The Carroll County Planning and Zoning Commission on October 18<sup>th</sup> was tentatively scheduled to review the concept plan from Freven Foundation LLC, for construction of phase 2 of the Gerstell Academy athletic facility and tennis courts. The proposed development is slated for the east side of Old Westminster Pike, south of Brown Road.

The Carroll County Board of Zoning Appeals is scheduled to consider conditional use requests for two projects in Finksburg. One project is the proposed Victory Springs assisted living facility. The proposed 15-bed complex would be constructed at Route 91 and Hughes Road. The public hearing will be October 25<sup>th</sup> at 9:30 a.m. in Hearing Room 3-4, lower level of the County Office Building. The board will meet October 24<sup>th</sup> to consider a request by a business that wants to put bed liners on pickup trucks at the corner of Route 91 and Sykesville Road.
